

## **COULSDON WEST RA UNDER THREAT**

### **BLOCK THE ROTHBERG COUP**

### **STOP THE RICKMAN HILL STEAL**

Why 3 of the 5 remaining CWRA Committee members elected at the last AGM consider these people to be totally unsuitable for any role running a Residents Association

**COULSDON WEST members are urged to take any and every opportunity to ensure these disreputable people do not gain control of CWRA**

**1 - LYNNE ROTHBERG**

**Why 3 of the 5 CWRA Committee members elected at the last AGM view this person as totally unsuitable for any role running a Residents Association**

Engaged in repeated dishonest and disreputable behaviour

**Made herself chairman by fraud, and when not even a member of CWRA**

Claimed her husband David was a member of the CWRA Committee when she knew this was untrue

Claimed falsely this made meeting quorate and David could vote her in as chairman when she knew this was improper

Forced former CWRA Committee stalwart Geof Hunt to resign, concealing committee activity from him, then sending vituperative emails when he challenged this

**Showed contempt for ordinary members of CWRA and their views and opinions – “If they don’t like it, they can leave”.**

Added people to the Committee without Committee approval, then put this on CWRA Twitter

Bullied and victimised committee members to get them to resign

Forced Committee to adopt her Code Of Conduct – then breached this repeatedly in serious ways

Asked CWRA Committee member of 4 years Jean Biggs to resign for no reason and said she could come back on later

Disrupted 7-9-20 committee meeting with **extreme verbal abuse and intimidation lasting over 1 hour**, defying meeting chairman + denying others a chance to speak

**Banned from Committee due to unacceptable behaviour - refused to apologise**

**In our view this person is totally unsuitable for any role running a Residents Association**

**2 - DAVID ROTHBERG**

**Why 3 of the 5 CWRA Committee members elected at the last AGM view this person as totally unsuitable for any role running a Residents Association**

Falsely claimed to have been elected as a member of the Committee when he knew that was not true - and when not even a member of CWRA

Made meeting falsely quorate and voted in LR as chairman when not entitled to do so

Popped in occasionally at committee to back up his wife, but made clear he had better things to do with his time

Never accepted as a Committee member during 2019 or 2020

Agreed to Lynne Rothberg’s Code Of Conduct – then breached this repeatedly in serious ways

Bullied and victimised committee members to get them to resign

Disrupted 7-9-20 committee meeting with **extreme verbal abuse and intimidation lasting over 1 hour**, defying meeting chairman + denying others a chance to speak

Claimed this disgraceful conduct was perfectly proper and appropriate

**Banned from Committee due to unacceptable behaviour - refused to apologise**

**In our view this person is totally unsuitable for any role running a Residents Association**

### 3 - YASMIN DUBASH

#### **Why 3 of the 5 CWRA Committee members elected at the last AGM view this person as totally unsuitable for any role running a Residents Association**

Engaged in repeated dishonest and disreputable behaviour

Being invited by Lynne Rothberg to attend committee, picked arguments with other members, including false accusations of racism

Agreed to Lynne Rothberg's Code Of Conduct – then breached this repeatedly in serious ways

Bullied and victimised committee members to get them to resign

Disrupted 7-9-20 committee meeting with **extreme verbal abuse and intimidation lasting over 1 hour**, defying meeting chairman + denying others a chance to speak

Banned from Committee after just one month due to unacceptable behaviour - refused to apologise

Created false "Minutes" of 7-9-20 meeting

Harassed committee members with endless nasty emails, especially Michael Southwell, Treasurer of 20 years and acting Chairman, who also received nasty phone calls

**Created FAKE NEWS – created bogus letter + put on Facebook + Twitter, also created false Inside Croydon story**

Ignored instructions not to phone or email other than by a specified email - wilful harassment

Turned up uninvited and knocked on doors dressed in disguise for no good reason, apparently to harass and intimidate, and in breach of virus regulations, at homes of MS, LA, JB, PJM – Lucy Acres being of 20 years standing on the CWRA Committee

**Reported to Croydon Police for harassment of elderly committee members**

**In our view this person is totally unsuitable for any role running a Residents Association**

### 4 - RICHARD WALKER

#### **Why 3 of the 5 CWRA Committee members elected at the last AGM view this person as totally unsuitable for any role running a Residents Association**

Never voted onto CWRA Committee

Engaged in repeated dishonest and disreputable behaviour

Agreed to Lynne Rothberg's Code Of Conduct – then breached this repeatedly in serious ways

Bullied and victimised committee members to get them to resign

**Harassed and bullied MS to get him to resign + wrongly transfer CWRA funds to himself + Keith Watkins**

Sent numerous rude, insulting and derogatory emails to MS, JB, PJM

Obtained JB's phone number and got angry, then hung up when Jean Biggs refused to resign

Mis-used CWRA database to access home addresses of JB, LA, and PJM - breach of DPA + GDPR

**Ignored instructions issued to avoid him causing further distress not to visit, phone or email other than by a specified email**

Turned up uninvited and knocked on doors dressed in disguise for no good reason, apparently to harass and intimidate, and in breach of virus regulations, at homes of MS, LA, JB, PJM

**Reported to Croydon Police for harassment of elderly committee members**

**In our view this person is totally unsuitable for any role running a Residents Association**

## **5 - KEITH WATKINS**

**Why 3 of the 5 CWRA Committee members elected at the last AGM view this person as totally unsuitable for any role running a Residents Association**

Never voted onto CWRA Committee

Didn't join CWRA for 3 months after Lynne Rothberg brought him to committee

Rude emails to other committee members over numerous issues

Very rude about efforts of JB, MS + PJM to produce CWRA Newsletter

Failed to offer promised content for that Newsletter

Frequently very rude and insulting in comments on material produced by MS, JB and PJM, including the finished newsletter

Refused to provide any further content

Posted numerous disparaging and insulting material regarding CWRA committee members on his Twitter account,

**Conspired with RW to induce MS to improperly transfer control of CWRA bank account to them**

**In our view this person is totally unsuitable for any role running a Residents Association**
